## SECTION 4 - FIRST-AID MEASURES

**Inhalation:** Call a physician or poison control center immediately. Move to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen.

**Skin:** Wash off immediately with soap and plenty of water, remove all contaminated clothes and shoes. Consult a physician.

**Eyes:** Immediate medical attention is required. Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Keep eye wide open while rinsing. Do not rub affected area.
